The Allen County Board of Commissioners met in regular session at 8:30 a.m. with Chairperson Thomas R. Williams, Commissioner Jim Talkington, Commissioner Jerry Daniels and Sherrie L. Riebel, Allen County Clerk.

Bob Johnson, Iola Register and Heather Bosler, Humboldt Union, were present to observe the meeting.

Commissioners approved the minutes of the March 31, 2015 meeting.

Bill Maness, District Representative for US Senator Jerry Moran, joined the meeting.

Ron Holman, Allen County House and Grounds Director, requested having a pin oak removed. Discussion followed. Commissioners approved the pin oak be removed and replaced. Ron suggested red buds.

Ron discussed a SEED grant program he has applied for to enhance the courthouse lawn.

Ron presented bids for painting the courthouse. Bids were received from Superior Builders LLC for \$48,685.00; Pro Painting & More for \$51,100.00 and Mid-Continental Restoration for \$68,430.00. Commissioners discussed not painting for a while, but will reconsider after the windows have been replaced.

Jana Taylor, Small business Group representative, requested to use space on the courtyard, if needed on May 9<sup>th</sup>, 2015. WHEREAS: Each dispatcher has exhibited compassion, understanding and professionalism during the performance of their job in the past year; and

WHEREAS: In recognition of the forgoing, the Senate and House of Representatives of the United States of America have designated the second week in April of each year as 'National Public Safety Telecommunicators' Week'

Ryan Sell, Allen County EMS Director, and Timothy Thyer, Iola Fire Chief, joined the meeting. Discussion on quarterly reports was discussed per type and quantity. There are some runs that are not charged for because of refusal of transport. Ryan stated some of the calls happen over and over for the same person, it is a service. Ryan discussed covering western Bourbon County since they are closer, but if Moran EMS is not available, they deny mutual aid. Discussion followed. Terry stated they average six runs a day.

Commissioners asked about staffing. They are currently at 29 staff including Tim and Ryan. Discussion followed. Chief Thyer stated there are a couple staff in paramedic classes.

Ryan stated the licensing time is here. They need to get a sign off on one ambulance that needs a windshield repair before they get approved for 2015-2016 licensing.

Carl stated they are starting the bid process for an ambulance and was wondering if the commission had an idea of what they are thinking. Ryan stated they are looking at Type A and Type B ambulances. Type A is a higher cost, but worth more in the end than a Type B. Discussion followed.

Ryan asked about Med Unit #31(International). It is not licensed and cost more to get it up to speed than it is worth. Discussion followed on sale on Purple Wave, keep in the county if motor and other options. Ryan will be visiting some of the manufacturers to view ambulances and specifications.

James Nixon, Diebolt LLC., reported there will be an auction on the 18th at the old Diebolt Lumber and it will be opening as Diebolt LLC. They will be doing model homes and such. James explained the current situation and why they filed a Chapter 11 bankruptcy. The economy is changing and they are looking to the future of home building. They would like the opportunity if the county would ever look at a building.
