Mitchell Garner, Allen County Public Works Director, Jeremy Hopkins, Allen County Road & Bridge Director, Rickie Aiello, Allen County employee, Bob Johnson, County Counselor, Anthony Maness, Sheriff, Sarah Haney, Iola Register, Susan Lynn, Iola Register, Tim Stauffer, Iola Register, Cliff Ralstin, Humboldt Union, and Paul Zirjacks, citizens, was present to observe the meeting.

Chairman Daniels led the group in the Pledge of Allegiance.

Commissioners approved the minutes of the January 14, 2025 meeting.

Commissioner Daniels asked for public comment. There was none.

Anthony Maness, Sheriff, reported the employee meetings last week went really well. February he will be revising schedules. Discussion followed.
