Shall Allen County, Kansas, be authorized to impose a one-quarter percent (0.25%) retailers' sales tax (the "New Sales Tax") for the purpose of financing health care services, including facilities, by Allen County Hospital, with collection of such New Sales Tax to commence on January 1, 2021, upon termination of the existing one-quarter percent (0.25%) retailers' sales tax collected in the County for health care purposes, and to expire on January 1, 2026, all pursuant to the provisions of K.S.A. 12-187 *et seq.*, as amended?
